Chair's Notes December 2022

Consultation on Winchester's Local Plan is open until 14 December

Winchester City Council (WCC) is preparing a Local Plan for development from now until 2039, including locations for new housing. You can respond to the consultation at https://winchester.citizenspace.com/policy-and-planning/local-plan-regulation-18/

This is your chance to **Protect the Gap** between Whiteley and Curdridge and have your say about other priorities in the district. The Parish Council has already asked for the Gaps policy to be amended to stop Whiteley encroaching closer to our village. Many plots of land along the A3051 were offered to WCC as SHELAA sites that their owners would be happy to sell for development. Although these SHELAA sites are not currently scheduled for housing we need the gap to be protected explicitly, to avoid the risk of development in future Plan updates.

To protect this vital piece of countryside, please use the consultation to tell Winchester City Council that the Gap between urban Whiteley and rural Curdridge should be protected within Policy NE7.

Road Closures for Coronation Street Parties

Yes, it's a long time until May 6th, but Winchester is expecting to be flooded with applications to close roads for street parties, so has set a deadline of Friday 3 February. If you are planning a street party and need to have your lane closed to vehicles, please apply in good time. Winchester might be able to consider late applications, but cannot guarantee it.

Parish Boundary

Thank you to all who responded to Winchester's consultation about the governance of north Whiteley. There was strong support – over 70% – for Option 2, which moves the boundary so the whole north Whiteley development is in Whiteley. The Advisory group running the review has recommended this outcome to WCC Licensing and Regulation committee. If that committee endorses the change on 7 December, it will be considered by the full Winchester City Council, with a view to making an order to move the boundary. Time is tight, as Whiteley Town Council needs all north Whiteley residents to be on the correct electoral roll so they can vote in its elections next May. Curdridge and Whiteley councils are both confident that this timetable is achievable.

Speedwatch

Have you seen Lynne Newton's Speedwatch team at the Allotment entrance, noting down vehicles speeding along Botley Road? Drivers exceeding 45mph get a letter from the Police, and it seems to work, as few get caught a second time. All past village surveys have shown that fast traffic is a major worry to parishioners, and Speedwatch helps to deter speeding through the village.
