Chair's Notes February 2023

Whiteley Bus Route

The new bus service to Whiteley and beyond is now up and running from Botley Station. The bus turns round by running along Reading Room Lane. At Councillor Newton's suggestion, we have asked if an additional stop could be provided by the Reading Rooms, to provide a service from Curdridge to the shopping centre in Whiteley. Hampshire County Council is actively trying to persuade the bus company to add this stop.

Curdridge-Whiteley Boundary

The second consultation about the planned move of the boundary raised no issues, so there is no need for the Licensing and Regulation Committee to review it. The full Winchester City Council will consider the recommendation on 18 January, with a view to making the order that moves the boundary so that the whole of the north Whiteley development is covered by Whiteley Town Council.

Contentious Planning Applications

The Parish Council has to be consulted about Winchester planning applications, but can only take a position in matters that are legally relevant to Planning. We can raise objections when an application goes against the local plan, or fails to protect landscape or wildlife, and we can also suggest conditions that prevent intrusion on neighbours or on the street scene.

Two recent applications have put the Council in the difficult position of having to tread a fine line between opposing interest groups. Our goal is to support everyone in the parish, but this can be very difficult. For example, a large number of parishioners want to have a viable pub in the village, but the success of the Cricketers has created parking issues in the area, and neighbours are concerned about the noise generated.

Similarly, the application to build four new houses at the top of Gordon Road will take away a view that those in the area have long enjoyed. At the same time, it would allow four new families to share the joys of living in the village. Curdridge has been lucky in not being forced to accept areas of new housing, despite pressures from central government, and the parish council has strongly opposed most of the sites offered under the SHELAA process.

Reading Room Heating

With the aid of a grant from the Parish Council, the Reading Room heating system has been repaired, and modified to make it more efficient.
