Parish Council Meetings

Although we intended to run our first-Thursday meetings informally on Zoom during the Omicron peak, the 6 January meeting had to be in person, so that we could approve the 2022-23 precept (funding Winchester collects to pass to the parish). This was set to leave the Parish part of Council tax unchanged.

Hampshire and Isle of Wight Air Ambulance

One of the less obvious consequences of the Covid-19 pandemic is that our local air ambulance is being called out almost twice as often as usual. That is because road ambulances are so much busier, and cannot always deal speedily with some of the most urgent cases. This means that there are occasions when they cannot provide the rapid hospital admission required, and have to transfer the emergency to the helicopter service provided by the air ambulance charity. This increases the number of airborne hours, which is a major expense for the organization.

North Whiteley

Outline planning permission for North Whiteley was granted before Winchester raised the environmental standards that apply to planning decisions, and this limits the City's powers when developers submit details in "Reserved matters" applications. Even so, developers are building to high insulation standards, but are leaving the installation of solar panels to the purchasers of the new properties. The parish council has been consulted on the detailed applications for phases 7 and 8, and commented on several aspects. Many of the dwellings in these phases have adjacent parking or garages, which makes it easy to install electric vehicle charging. However, no cable ducts will be installed to remote parking spaces, making it expensive to add charging facilities later.

Affordable Housing – Botley Road, next to St Peter's Close

At the time of writing, we are still awaiting formal planning permission. Tender packs have been sent to eligible contractors, with responses due in early February.
