Progress with the Planning Vision for the Parish

Following the successful community consultation events about the future of our villages, we have been working through the responses received and the questionnaires. We have been delighted with the number of parishioners who have taken part and we will be publishing the outcomes early in 2024.

Smart Marketing, who facilitated the consultation and analysed the survey findings, have now produced a thick document containing the feedback, including all the comments you made. The next step is to identify the main themes and use charts to illustrate them and stimulate further discussion.

During January, every household will be receiving a summary of the feedback from the initial consultations, and an invitation to a second round of events that will help us to produce the Vision 2050 document and set out the road map for the production of a Neighbourhood Plan.

We will be looking for volunteers to help with the Neighbourhood Plan from the summer of 2024. Anyone interested should contact Cllr Carkeet (Cllr.carkeet.cpc@gmail.com).

Playground

One theme that already stands out in parishioners' feedback is that the village needs a much better play area. Although the Parish Council owns some land in the village, we feel that it would be much better to support the Reading Room trustees in replacing the existing play area. This is in a focal point for the village, with excellent parking, and they already have a fundraising project involving the School Association and *The Cricketers*.

Co-option Vacancy

I'm sorry to tell you that our most experienced Parish Councillor, Lynne Newton, has announced that she will be moving from the village in February, and will therefore be standing down from the Council. Lynne is well known to many of you, as she walks round the village and its footpaths, often with neighbours' dogs. She will be a hard act to follow. We will start advertising a co-option vacancy in January, looking for someone with as much enthusiasm and drive as Lynne as we work out new directions for the villages. The Council represents Curdridge and Curbridge, and we would welcome applications from people living anywhere in the parish.
