P28.1 Telcom Site Kitnocks Farm, Outlands Lane, Curdridge, Hampshire – Replacement of 3no. antennas, installation of 1 no. 600mm diameter transmission dish, one equipment cabinet and development ancillary thereto. Case Officer: Mrs Katie Nethersole. Case No: 15/02237/FUL. The Chair introduced this item. *Resolved to make NO COMMENT on this application*.

Cllrs Furby and Weaver had visited this property and felt the application would have no impact on its surroundings.

Resolved DO NOT OBJECT & SUPPORT this application. ACTION: CLERK.

P29. To consider/decide if Council wishes to comment on the Planning Application submitted to Eastleigh Borough Council for land north and east of Boorley Green, Botley, Southampton, SO32 2BX - Reserved Matters Application (Pursuant to outline planning permission O/12/71514 which was subject to an Environmental Impact Assessment) for the spine road infrastructure together with foul and surface water drainage networks, landscaping and associated works. This application includes the diversion of Footpath No. 2. Case Officer: Liz Harrison. Case No: R/15/77552. Members discussed this application in detail.

Resolved that Cllr Bodger would draft a response to EBC incorporating that traffic exiting from the Southern exit should not be prioritised onto Maddoxford/Wangfield Lane, East bound towards Curdridge and also making EBC aware of the proposed "safe route" to be used for the Botley to

Bishops Waltham Trail. This would be circulated to Members and forwarded by the Clerk to EBC and Cllr Humby, requesting him to highlight CPC's response to HCC. ACTION: CLERK.

To consider/decide if Council wishes to comment on Planning Application submitted to HCC for erection of an additional feed hopper and conveyor, the construction of a small scale aggregate storage bay, and the relocation of existing sand storage bay to serve the rail fed asphalt plant at Foster Yeoman Ltd, Station Hill, Curdridge, Hampshire SO30 2DN. Curdridge Parish Council would also like Hampshire County Council to note its request that a 30 mph speed limit be implemented on the road immediately outside of this property entrance, as this is an extremely dangerous road and access. ACTION: CLERK.

- P31.4 Harfield Farm Botley Road Curdridge Hampshire SO32 2DU Erection of 2 bay oak framed timber clad garage with storage room above and roof light windows to the rear. (WITHIN THE CURTILAGE OF A LISTED BUILDING). Case Officer: Lisa Booth. Case No: 15/01984/LIS. *NOT REOUIRED*.
- P31.5 Tabithas Cottage Botley Road Curbridge Southampton Hampshire SO30 2HB (HOUSEHOLDER) Single storey side extension with log store following removal of existing greenhouse. Case Officer: Mrs Katie Nethersole. Case No: 15/02220/FUL. *APPLICATION PERMITTED*. The planning decisions were noted.

Resolved to make no comments to this Part 2 Local Plan Consultation.

P33. To consider whether Council wishes to respond to Hampshire County Council's Draft Walking Strategy Consultation (previously circulated to Members)

Resolved that the Clerk would revise HRVF recommended response by:

- i) Revising bullet point to "supporting and extending the English Coastal Path proposals and adding Botley and Curdridge";
- ii) Revising bullet point to "transforming disused railway lines into bridleways and footpaths, e.g. the Botley to Bishops Waltham Trail" and ensuring that such routes are set up as safe routes;
- iii) Revising bullet point to "extending orphan paths that stop, sometimes at parish boundaries e.g. Curdridge SU533127 (Shedfield Footpath 10) and where necessary investigating imposing compulsory purchases to create safe routes to avoid busy road;
- iv) Adding an additional bullet point "Ensuring that all footpath surfaces on well used footpaths (i.e. near housing) are well maintained to enable walkers to use these routes to commute to work, shops etc;
- v) Adding an additional bullet point "Ensuring where possible that all footpaths created are not urban and should rather be wider, wild life corridors;

vi) Adding an additional clause "Ensuring that all pavements are well maintained, i.e. surfaces maintained, drainage cleared and encroaching hedges cut well back, to enable walkers to use them safely.

Revised response to be circulated to Members for any comments to enable response to be submitted by the deadline. ACTION: CLERK.

Clerk to write to HCC Highways requesting that Botley Road from St Peters Church at Curdridge through to Botley be inspected with a view to ensuring that roadside hedges are fully cut back, pavements repaired and drainage cleared. **ACTION: CLERK.**
