Meetings

Given the resurgence of Covid-19, the Council decided to continue meeting online until the end of April 2021. Power Supply Problems

Although power failures are less common in Curdridge than they were in the 1980s, there are still some parts of the village that suffer too many power cuts. Scottish and Southern Electricity Networks, who provide the supply to our houses, replied to a complaint from the Council saying "*I am sorry that there have been supply issues within Curdridge recently. Our depots are aware of the faults and will be carrying out further investigations to ensure our network is as resilient as it should be.*" You can phone 105 to report an outage or use the free number (08000) 72 72 82. Ice on the Roads

Hampshire Highways has been dealing with cold snaps by salting main roads and "community routes" (mainly roads to schools and healthcare facilities). For the smaller roads that are not treated by County vehicles, there are bins of salt and grit around the village, which residents can use to make nearby roads passable; it only takes a tablespoon of salt per square metre to clear ice. Parish councillors have been out clearing brambles and other obstructions from around the bins, most of which are blue.

Affordable Housing

The working group continues to push ahead on this project, though it feels rather slow because of the many surveys and reports that are needed for the planning application. It is unlikely that the application can be submitted before April, but it's better to tie up all the loose ends than to risk Winchester refusing planning permission. The group met again to track progress, and to rehearse our presentation for the national event on Community-led housing being run by the Hampshire Homes Hub on 19 January.
