## February 2017 Planning Matters

Following various disputes throughout 2016, Parish Councillors are aware that feelings sometimes run high amongst residents in respect of neighbourhood property planning. For those of you who are unaware of the process, applicants will usually be required to display an orange notice prominently outside the property advising of the proposal; immediate neighbours of the property will be contacted directly by Winchester City Council. This gives you an opportunity to raise any concerns with Winchester City Council's Planning Department. Their website will have information relating to planning applications that have been received, and will usually also have any comments and objections that have already been made.

To object - or to support write to the Planning Department and quote the planning application number. There is a comments section on the website where you can do this, otherwise post or email is fine. Comments will be needed within a time limit, usually twenty one days. It is generally best to make your objections known as soon as possible.

The Parish Council are informed of any planning application made in respect of a property in Curdridge or Curbridge and two Councillors will usually visit the property to view the proposed alteration/ addition. The Parish Council is merely consulted by Winchester Planning, who must take our views into consideration, along with representations from neighbours and the public. The Parish Council has to consider all applications within strict planning criteria, treating each application on its own merits. We are prohibited from considering events that might potentially follow planning approval, though we can recommend conditions that would constrain future overdevelopment.

The Parish Council usually meets on the first and third Thursday of each month in the Reading Rooms, at 7pm. Planning Applications are discussed and a report is made to full Council of any visits which have been made. All interested parties are encouraged to come along to these meetings to object to, support or comment in any way on the application, so that the Parish Council can be made aware of how an application is viewed by neighbours. The Parish Council then agrees its comments on the proposal and forwards them to Winchester City Council's

Planning Department. It is they who make the final decision.

If you are considering putting in a Planning Application yourself, you are very welcome to contact the Parish Council to present your ideas (even before you have plans formally drawn up), although we are unable to give any formal indication of whether an application would be supported or objected to, as this could be considered as predetermination. *Cllr Christine Weaver - on behalf of*
