21.61 Cricketers Pond – motion by Councillor Newton to replace the chain post and chain link fence on the Botley Road boundary with picket fencing

Members welcome this discussion. Councillor Newton had checked the post and chain link fencing which now needs replacing as a couple of the posts are very rotten. She suggested continuing the picket fencing from Calcot Lane along the Botley Road boundary of the pond. Members queried whether picket fencing would interfere with the visibility at this dangerous junction, as HCC would make Council remove the fencing if it did. Cllr Newton advised Members that she had thoroughly checked whether having picket fencing would affect visibility from Calcot Lane onto Botley Road for drivers and assured Members that picket fencing along the same line as the current post and chain link fence would not interfere with visibility at all. Resolved to continue the picket fencing from Calcot Lane along the Botley Road boundary of the Cricketers Pond following the same line as the current post and chain link fencing on this boundary and to use the same contractor to carry out this contract, as he had proven to be the most competitive and had also done an extremely good job. ACTION: PCM.
