## CHAIR'S NOTES JUNE 2018

The residents of **Woodview Park** have contacted us more than once about the vegetation which grows alongside the railway bridge parapet and obscures their view of the traffic hurtling down from the top of Station Hill. Residents report that they often turn left and then turn round in the petrol station rather than risking trying to turn right as they exit. I am pleased to report that we have at last got Highways to clear the vegetation and (hopefully) restore the sightline. We have asked them to confirm that this will now be part of their regular verge-cutting programme. We have supported previous initiatives by other local Parish Councils to tackle the issue of noisy, speeding and dangerous motorbikes. The problem is greatest on the A32 (Meon Valley) and on the A272. However, we also have our share of this nuisance and have just given our renewed support to a new body, Community Against Noise and Speed, which will lead on this issue.

As part of the North Whitelev plans, a combined cycle and pedestrian path is going to be built alongside the A3051 from near Fairthorne Grange Farm to King's Corner. We welcome this plan, but not the intention to light it with five meter high lamp posts. I attended a Botley Parish Council meeting to seek their support for our opposition to these lights. I am pleased to report they gave their support, though disappointed that they felt some low level lighting should be installed. We have argued that there is no need for and that there should be no lighting through this rural, heritage landscape. I hope to speak to Whiteley Town Council about this soon.

The Parish Council is planning to create an e-mailing list for those who would like to receive information from us electronically. This would include monthly Chair's Reports, other notices as already appear on our notice boards and other occasional communications concerning PC business. We promise our e-mails will not fill up your in-box ! If you're interested in being on our e-mail list please sign up via the Parish Council website. All Parish Councillors were due for election in May this year, however, as there were only seven candidates for the seven posts no election was deemed necessary and we were all returned unopposed. This includes a new member, Councillor Debbie Caister, who lives in Curdridge. We welcome Debbie to our ranks. Kevan Bundell
