## Chair's Notes - May 2017

As you may have noticed, the work on the iunction of Curdridge **Lane and Lockhams** Rd has now been completed. Not only has a kerb been put in and the curve been made sharper but a pavement has also been laid. This should make the corner safer for the many pedestrians that walk this way. Mind you, no sooner was it done than a tyre track was to be found on the new grass area between the kerb and the pavement. Perhaps steering is no longer included in the driving test? Our next Highways priority is to have the speed limit reduced on Kitnocks Hill from 50 to 40 mph. This follows two loss of control incidents where cars ended up crossing the pavement, narrowly missing, in one instance, school children walking home from the bus stop. I met with Councillor Rob Humby and a senior Highways officer at HCC recently to discuss this and other road-related issues. Unfortunately my lobbying efforts met with no success on this one. Given their limited resources and their responsibility for the whole of Hampshire, Highways have a policy of prioritising where there has been a pattern of accidents involving iniuries or fatalities. Kitnocks Hill does not qualify. I did only slightly better on reducing speed limits through Curbridge and on Station Hill, including the possibility of a pedestrian crossing point between Woodview Park to the bus stop and station. It was agreed that these could go on a list for review once North Whiteley and other developments, which will lead to increased traffic on our roads are

underway. Meanwhile the PC has agreed to extract the speed data from our flashing speed limit reminder device and send it to Highways as part of our lobbying effort for reduced speed limits.
