## **CHAIR'S NOTES OCTOBER 2017**

As I reported here last month, a Planning Application has now been submitted for the Botley By -pass. The Parish Council is concerned that a safe crossing point is provided where the proposed Botley to Bishop's Waltham Trial will cross the by-pass. Councillor Newton has been working on the Parish Council's behalf - together with others - for some years to establish this trail, which will be available to pedestrians, cyclists and horse riders. Councillor Bodger has been leading our response to **Eastleigh Borough's** plans for Botley, Boorley Green and Woodhouse Lane which - together with North Whiteley - we expect to add considerably to the traffic through the village particularly in Wangfield Lane and on to the B3035. Boorley Green is already being built of course. There are now also plans for large scale development to the east of Winchester Street in Botlev and to the North of Woodhouse Lane. There will be a public exhibition on these plans from 2pm to 8pm on Friday, 22 September 2017 in the

Diamond Jubilee Hall, Botley.

The Parish Council owns a small part of the car park at the Horse and Jockey in Curbridge. We lease our part of the car park to the pub/ brewery in return for their allowing public access to the Parish Quay, which is well used by kayak folk and the like. However, the car park is privately owned by the pub/brewery. The pub landlord has consulted us on plans to introduce a small charge for parking because the car park is frequently being filled up by people using the guay, going for a walk in the woods or even just having a picnic on the pub's bench-tables without using the pub. The charge would be refunded if people do use the pub.
